13. The total gross Octroi receipts in 1904-05, amounting to Rs. 1,63,996 when compared with those of the previous year (Rs. 1,54,475) show an increase of Rs. 9,521 which has accrued chiefly under the items of cloth, metal, fuel and other articles of food. That on cloth and fuel alone accounting for more than $\frac{2}{3}$ of the total increase, which may probably be ascribed to the severe winter.

61. The result of the deliberations of the Finance Sub-Committee on Mr. F. C. Mehta, Vice-Chairman's report, referred to in para. 60 of last year's report, was that the Head Moharrir was reduced and sent to another Department.

Octroi Office.

62. The Schedule adverted to in para. 61 of last year's report was duly revised as required, and submitted for sanction *vide* General Committee's Resolution I, dated the 6th, 7th and 12th September 1904 ; orders on this are still awaited.

Octroi Schedule.

The Octroi Rules were returned for further revision and this is being done.

63. The report of the Special Sub-Committee referred to in para. 62 of the previous year was submitted to you with this Office No. 1567, dated the 5th December 1904. The General Committee has decided to carry out the recommendations of the Special Sub-Committee in order of their importance, with the sanction of the Local Administration, which being summarised are as follow :—

Public Health and
Sanitation.

- (1) That the further erection of private latrines in courts or lanes less than 10 feet wide, or where the ventilation in the opinion of the Civil Surgeon is insufficient be refused. Latrines in upper stories which cannot be served from outside be altogether prohibited. To meet the increasing wants of the population moveable iron latrines served by Municipal sweepers be erected on convenient sites in Dara Chaudar Mohalla, Dara Shorgaran, Gujar Mohalla, Hindri Gandian, Nahr Mohalla, Chah Khari, Ghaseti and Motikatla.
- (2) That the existing " Birat " system should remain, but should be placed by Regulation under the control of the Municipality. All sweepers to be registered and licensed, and liable to dismissal or punishment for neglect of duty. This would necessitate also the registration of all private latrines, which should be numbered and apportioned to the registered sweepers.
- (3) That the four foul-water collecting stations, which are now thickly surrounded by houses, be abolished. The foul-water to be removed direct from the houses to the Tramway Station by providing two iron receptacles of a standard pattern for each private latrine at the cost of the owner ; these would be placed on Municipal hand-carts and removed daily, the full receptacle being replaced by an empty one. Where there are no private latrines, the Municipality to provide the necessary receptacles

at convenient places for the deposit of foul-water, to be similarly removed. The estimated cost of 1,200 such receptacles is Rs. 3,000 (1,200 × Rs. 2-8), and the cost of 100 hand-carts, Rs. 5,000 (100 × Rs. 50).

- (4) That the Jharoka rules be rigidly enforced. That no new building be permitted except on approved plans. That in crowded parts of the city, buildings which fall down be not rebuilt, but the land acquired by the Municipality and kept open. That a Special Sub-Committee should deal with the increasing settlements in the suburbs, *e. g.*, the village to the South of Railway Carriage and Wagon Shops and that to the East of the Nasirabad Road.
- (5) That the covered drains in the Naya Bazar be first converted into open saucer drains, and the system be extended as funds permit. The estimated cost for the Naya Bazar is Rs. 4,100. That surface depressions and excavations should every where be filled up. That the narrow and badly drained lanes in the city be paved as funds are available in each year. That the surplus water from the Railway Loco and Carriage Shops to the east of the Nasirabad Road be carried off. That the Nalla from the Anasagar lake to the Bisla tank be graded both within and without Railway limits. That masonry platforms be made round all city hydrants, to prevent spillage of water, and the cisterns be enlarged where they are too small. That one-fourth of the whole of the city roads in charge of the Municipal Overseer be entirely renewed every year.
- (6) That steps be taken at once to have the requisite survey carried out for a large scale map of Ajmer city and suburbs, which is a very important adjunct, with a view to carrying out the improvements recommended. The cost, as estimated by the Superintending Engineer would be about Rs. 12,000.
- (7) That the city wall south of the Madar-gate be dismantled, and a thoroughfare constructed from Madar-gate to the road leading from Ahta Mohalla to the camping ground. That the road between the Lal Phatak and the Post Office be improved by constructing raised side walks, metalling the whole road, and planting trees. That the lighting of the city, and suburbs be improved, especially on the Beawar and Katchery Roads by electricity, if this is feasible. That an estimate be made of the cost of steam tramway for the removal of refuse to the trenching ground. That the Executive Engineer be requested to report on the possibility of increasing the supply of water to the Foyasagar lake, Anasagar lake, Bisla tank, and Bibi-Chilla tank.

64. Owing to the unserviceable state of the major portion of the present stock, arrangements have been made with Messrs. Conservancy Rolling Stock. Burn & Co., of Howrah for supplying the following :—

Hoppers	130
Cart frames complete	13
Wagon frames complete for Tramway	12

At an estimated cost of Rs. 13,300 exclusive of incidental charges, out of which the following have been received :—

65. Tariffs of rates were framed for Foyagar and Pushker, and the Local Administration was moved to extend the Hackney Carriage Rules to these two places under Section 5 of the Hackney Carriage Act. (XIV of 1879) *vide* General Committee's Resolution I, dated the 17th November 1904, but no reply has yet been received on the subject.

66. A Special Sub-Committee was appointed to reorganize the Head Office and Octroi Establishments, and their proposals which have been accepted by the General Committee will shortly be submitted to you.

67. An estimate amounting to Rs. 6,196 for laying a 3 inch chord pipe-line along the Railway Mall at Municipal expense and the draft agreement with the Railway for the supply of water were submitted to you for proper sanction and a reply is awaited.

68. Owing to the danger and detention caused to wheeled traffic and foot passengers at the crossing, known as the Lalphatak, which is one of the main entrances to the city, the Local Administration, was moved to address the Government with a view to causing the Railway to provide a Bridge for both vehicles and foot passengers. A reply to this reference is awaited.

69. It was decided by the Committee to license all dyeing houses within the Municipality and to charge a fee according to the number of hands employed, as the throwing of refuse-water from such houses into the street was considered offensive and dangerous to the residents of the neighbourhood, and one of the causes of ill-health in the city. The question is still pending final settlement.

70. Section 128 of the Ajmer Municipalities Regulation of 1886 was amended with a view to compelling bullock-carts to carry lights after dark.

71. The laying out of a garden round this tower as desired by the District authorities is in hand, and will be completed as soon as possible.

72. The ground below this wall is being improved, and will be planted and fenced as early as practicable.

73. Rules regulating this Mandi and relating to the permissive use by shop-keepers of street-land opposite their respective shops were passed by the Committee and submitted for confirmation, which is awaited.

74. Authorised butchers were permitted to convey meat to the houses of their regular customers subject to the conditions that the meat was not exposed and that no hawking was done.

75. The Committee appointed a temporary clerk at the Railway Station to furnish the supervisors in all the city wards with a daily statement of new arrivals into the city from plague infected areas. At the junction of the Beawar and Nasirabad Roads with the Military Road to Taragarh, two inspecting outposts were opened. Forty scavengers were employed to clean the city and suburbs and 16 bullocks to work 8 extra carts were hired. Conservancy receptacles were issued where necessary and sulphur and rosin, were burnt in the streets where required. To meet the above expenditure a sum of Rs. 2,000 was placed at my disposal by the Committee. In spite of precautionary measures, the plague appeared in the city in the month of March 1905, having been imported into Ajmer, from Nasirabad, and continued till the 27th May 1905. 129 local cases were reported from March to May 1905, all of which were fatal. Since 27th May there has been no recurrence of the outbreak.

76. The management of such properties is vested in the Municipality but as they were entrusted to the Municipality from time to time without any list, it has been found necessary to compile a detailed Register of them, which has been under preparation by the Municipality for some time.

The Register is, however, still incomplete for want of certain information, which is being collected from various sources, and every effort is being made to push on its completion. The properties have been classified at present as follows :—

CLASS I.—Unproductive of which there are 30 in number.

CLASS II.—Productive of which there are 34 in number.

CLASS III.—Special of which there are 9 in number.

CLASS IV.—Doubtful of which there are 3 in number.

CLASS V.—Properties already sold or alienated outright of which there are 4 in number.

Those that are productive are leased annually, and the rents credited to Municipal Funds, which are applied to the maintenance of the properties and to the reduction of debt as ordered by the Local Administration.

It may be noted that the building in the Naya Bazar known as the "Purani Sayar" was surrendered to the Imperial Government during the year.

77. The land lying between, the Balapura Road, Katcha Road to the Mayo College and Nasirabad Road situated near Narana Bhyron, was demarcated for the guidance of intending builders with a view to ensure the construction of houses free from sanitary defects *vide* General Committee's Resolution XI, dated the 5th May 1904.

The construction of buildings in Longia outside the Delhi Gate, and in the locality known as Narana Bhyron on the Nasirabad Road were also regulated *vide* General Committee's Resolutions III and IV, dated the 21st September 1904.

78. The ground rent of these sites was fixed at the rate of Rs 2, per 900 square feet for a period of five years from September 1904, *vide* your endorsement No. 2952, dated the 16th August 1904.

79. During the year final orders were received in regard to the closing of certain objectionable grave-yards concerning which appeals had been lodged in your court, *vide* your No. 783, dated the 28th February 1905.

80. The Committee has decided to gradually increase the width of these in the city whenever an opportunity affords itself, *vide* General Committee's Resolution X, dated the 12th December 1904.

81. The masonry cistern near the Diggi latrine for storing foul-water, prior to its removal to our Tramway station, was demolished in consequence of complaints received from the residents of Kaisar Ganj, and it was decided that the foul-water from the city should be removed by Municipal carts.

82. The growth of the population and trade of Ajmer of late years has considerably increased the work of the Municipal Office with the result that arrears have accumulated, notably in the hands of the Municipal Overseer and Inspector. In the Head Office also it has been found difficult to deal with all the work with the existing subordinate staff. The Secretary and Assistant Secretary, in addition to numerous current duties, have worked hard to clear up arrears, and the number of outstanding cases has been considerably reduced. The strengthening of the Municipal staff has occupied my attention and that of the Committee for some time, and I hope that the proposals now being made will have the effect of rendering the despatch of business more prompt in future, with the assistance of the members of the Municipal Committee.

I must acknowledge the ungrudging labours of the Secretary and Assistant Secretary, as well as the cordial co-operation of the Members of the Committee, who have attended a larger number of General Meetings than in any previous year, the number of such Meetings this year being 36 as against 23 last year, in addition to the Sub-Committee Meetings, which rose from 120 to 128.

The revenue from Octroi shows an increase of R. 9,521 from last year under the careful management of the Octroi Superintendent, Munshi Bhairon Narayan, and the Conservancy Tramway service has been worked with efficiency and regularity under the charge of one of the Municipal Commissioners, Munshi Alanur Khan, who has performed this duty for the last 7 years.

I have already referred in the body of this report to the number of essential improvements which the Committee have lately projected, the execution of which appears to be warranted by the steadily increasing financial stability of the Municipality, and for which I would venture to ask for the careful consideration and assistance of the Local Administration.

ANNUAL REPORT ON THE AJMER WATER WORKS
FOR THE YEAR 1904-1905.

MANAGEMENT.

1. The management of the Ajmer Water Works is in the hands of the Executive Engineer, Ajmer Provincial Division with Babu Narayan Dass, Sub-Engineer, Sub-Divisional Officer, Ajmer, in direct charge.

SCOPE OF REPORT.

2. This report deals both in regard to statistics of water consumption and financially with the period included between 1st April 1904 and 31st March 1905.

RAINFALL.

3. The total rainfall from 1st April 1904 to 31st March 1905, as registered at the Reservoir was 16·81 inches (mean of 3 gauges, *viz.* one on the top of the dam, one behind the dam and one in the catchment).

As registered at Ajmer (Executive Engineer's Office) the rainfall was 14·88 inches.

From 1st April to 31st May 1904, the rainfall was 0·86 of an inch.

The water in the Reservoir reached its lowest level *i.e.* 11·96 feet below waste-weir on the 5th July 1904, and began to rise from that date. The rainfall during the monsoon months was as under :—

The rains practically ceased on the 25th August 1904, and the water in the Reservoir which had first reached the level of 20·70 feet above the sill of sluice on the 25th August 1904, began to fall from that date.

There was no rain in the months of November 1904, to March 1905, excepting 0·22 of an inch in December 1904.

RESERVOIR.

4. A table is given below, showing dates of filling, &c., of the Reservoir for the year 1904-1905. The total depth of tank between sill of sluice and low level waste-weir is 24 feet, the high level waste-weir being 25 feet above sluice :—

5. The water surface stood 16·52 feet above the sill of sluice on the 1st April 1904 and reached its lowest level of 12·04 feet above the sill of sluice on the 5th July 1904. The fall from the 1st April 1904, to the 5th July 1904, was 4·48 feet as against 6·54 feet (difference of level between 1st April 1903 and lowest level on 13th July 1903) in the previous year which represents a loss of 33·16 millions cubic feet in 95 days.

6. The town supply measured during that period was 7·72 millions cubic feet.

The difference of 25·46 millions cubic feet represents the loss by evaporation, percolation and absorption.

7. The water surface began to fall on the 25th August 1904, (on which date it was 20·70 feet above the sluice) and by the 31st March 1905 had reached a level of 15·08 feet above the sill of sluice. This represents a loss of 52·49 millions cubic feet in 219 days from the 25th August 1904 to 31st March 1905. The highest level was 20·70 feet on the 25th August 1904 after which the surface fell continuously daily without rising on any day.

8. The town supply measured during the above period was 20·33 millions cubic feet. The difference of 24·96 millions cubic feet represents the loss by evaporation, percolation and absorption.

9. The first fall of monsoon rain was recorded on the 30th May 1904 but it gave no rise to the surface of the Lake which commenced rising from the 6th July 1904, the intermediate showers of rain also having had practically no effect in raising the level of the lake.

 RAINFALL.

During the year 16·80 inches of rain were registered in Ajmer against 18·28 inches last year, the average of previous six years being 16·27.

The rainfall in the first half of the year exceeded the normal quantity, but from June to September (the months of the rainy season) the fall was 13·35 inches only as shown below or 4·16 inches less than the previous year.

 WATER-SUPPLY.

As before good water in sufficient quantity was obtained from the Municipal Reservoir. The only disease attributable to impure water prevalent in Ajmer is Guinea-worm. During the year pipes have been extended so as to supply water to the Mayo College and the Eastern part of the Civil and Railway lines between the Mayo College and the Military limits. This has been a great boon to the residents of these suburbs, though it is possible that, as it has led to cultivation of gardens, it may tend to encourage conditions favorable to the development of Malaria.

 VITAL STATISTICS.

The total number of deaths reported during the year 1904-05 in Ajmer City and Suburbs was 3125 against 3523 last year, a decrease of 398. This gives a death rate of 42·32 per 1,000 of population against 47·71 last year.

Out of the total mortality the number of deaths among children under five years of age was 1,521 (a percentage of 48·67 of the total mortality) against 1,793 last year. The decrease in the death rate may reasonably be attributed to the better general health of the people.

No cholera appeared during the year under report.

The total number of deaths from small pox was 256 against nine last year. The disease was prevalent at the end of the cold weather. The epidemic demonstrated the value of vaccination in a remarkable manner, the poorer classes, who are mostly vaccinated escaping the contagion, while the Bunnias and certain Mahomedans who object to vaccinations suffered considerably.

There were 1189 deaths attributed to fevers against 1494 showing a decrease of 305.

The total mortality from Bowel complaints was 220 against 315 in the previous year.

The Respiratory diseases account for 220 deaths against 209 in 1903-04,

Plague.—Ninety-five cases with fifty-six deaths were reported during the year under review against 71 cases and 32 deaths last year. With the exception of three all were importations from other places by train or road and were treated in the standing plague camp. In March three local cases occurred in Ajmer City. The patients were removed to the camp where they subsequently died. The infected houses were emptied and disinfected.

There can be no doubt that the local infection of Ajmer is due to the incursion of large numbers of fugitives from Nasirabad in February and March.

It is believed that the Medical inspection of all trains arriving at Ajmer has been effectual in delaying the invasion of the disease into the Ajmer City.

Births.—The total number of births registered during the year was 1801 against 1475 in 1903-04, an increase of 326.

The birth rate per 1,000 for the two periods was 24.39 and 19.98 respectively, an increase of 4.41 per mille.

The increase in births may, I think, be attributed to the improvement in the general health of the population during the year.

The number of deaths exceeded births by 1324. The bad sanitation of Ajmer City, which is practically irremediable to any extent, and failure to report births account for this difference. All deaths are known, whereas a large proportion of the births are not, and this will continue until parents and heads of houses are made to report births themselves and people substantially fined for not reporting.

VACCINATION.

The total number of vaccinations performed in the Ajmer Town and Suburbs during 1904-05 was 3,651 against 2,588 last season, an increase of 1,063 vaccinations.

Of the total number 3159 were primary vaccinations and 492 revaccinations against 2,552 and 36 respectively last season. Thus primary and revaccinations show an increase of 607 and 456 respectively as compared with last year.

CONSERVANCY.

Rs. 53,114 were spent on public health during the year under report as compared with Rs. 64,437 last year.

The amount of solid and liquid filth removed by the Conservancy Tramway fell from 88,52,625 to 86,07,875 gallons.

The scavenging of the city, which is mainly in the hands of privileged private sweepers, continues unsatisfactory, though steps are now being considered with a view to improve matters. During the year certain improvements have been made *viz.*

- (1) Extension of the Municipal trenching ground for the disposal of the sewage in shallow trenches and by the Nagpur system.
- (2) Purchase of new carts for the removal of solid and liquid matters from the city to the Tramway Station.
- (3) A large collecting tank for liquid excreta outside the old Usri gate has been abolished as a nuisance, and Conservancy carts now remove these fluids direct to the Tramway Station.
- (4) The Municipality has established the principle that new balconies and new private privies are not to be allowed in very narrow streets, where the former would interfere with free ventilation and the privies further pollute the stagnant air.

SIR,

With reference to your letter No. 454 dated the 22nd April 1905, I have the honor to submit herewith my brief report to be included in the annual report.

(1) Many of the streets of my ward require pavement very badly they are as follows :—

(a) Gali Choonpazan.

(b) Gali Khazanchiyan.

(c) Gali from Punditji-ka-Kowa, up to Holi Dara where we have pavement already.

(d) Gali Phulwalan.

(e) Mohalla Saraogiyan and bye-lanes.

(2) A number of Hydrants say about six or seven have been removed and stopped therefore a sufficient number of Hydrants should be erected on suitable sites to be pointed out by me.

(3) The present number of lanterns in this ward is insufficient and therefore a sufficient number of lanterns should be increased.

(4) The city roads of my ward are in very miserable condition and require a new coating and kept in proper repair but this present system of annual paching is not sufficient.
